Privacy Policy

Protecting your private information is our priority.

This statement of Privacy Policy applies to www.growwealthgroup.com, www.myfirstdealormillion.com, Grow Wealth Group LLC (“GWG”), and all divisions and entities of GWG and governs data collection and usage.

For the purposes of this Privacy Policy, unless otherwise noted, all references to GWG include www.growwealthgroup.com and www.myfirstdealormillion.com (the “Sites”) and Grow Wealth Group LLC. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, GWG may collect personally identifiable information such as:

We do not collect any personal information about you unless you voluntarily provide it to us. Tracking User Behavior
